Mama Bear's offers high quality funded places for up to 24 hours a week to qualifying families for 47.5 weeks of the year. To enable you to make full use of your entitlement across the week these can be taken across a variety of sessions during funded periods as per the table below. As the Government funding does not cover the costs of meals, snacks, nappies, other consumables, and non-curricular services & resources, these are provided as a separate "Bear Necessities" package. Funded sessions / hours can be combined with fee-paying sessions to give the best fit for your family's needs.

* **"Bear Necessities"** is our package of care items including everything your child needs that isn't covered by the Government funding: meals (breakfast, lunch, tea, as appropriate), healthy snacks, drinks, fruit, weaning food, nappies, wet wipes, barrier and sun creams, as well as all other consumables, enrichment and non-curricular services & resources that are not covered by the funding but otherwise included in fee-paying sessions. We supply these so you don't have to worry about getting everything ready yourself. This service is automatically provided at the session rates above. If you would like to opt out of this service and provide these items yourself please discuss this with the Nursery Manager, who will explain our policy on opting-out and what alternatives you will need to supply.

** Where sessions are part-funded, the balance is charged at the prevailing hourly rate. Where a booking pattern consists of varying session lengths, funding is first applied to the longer sessions.

Funded Sessions (also known as Early Years Entitlement or EYE):

All Entitlements start from the term after the child's qualifying birthday. For full details and term dates please see our Early Years Entitlement policy. Also see [Best Start in Life](#) for more information on help with childcare fees. No registration fee is charged for funded-only sessions or bookings where only a Bear Necessities charge is made, however, a registration fee of £100 applies to access a part-time fee-paying place (fewer than 40 hours per week), whilst a registration fee of £150 applies to access a full-time fee-paying place (40 or more hours per week).

Fees: Where payable, fees are due on the first day of each calendar month in advance, by Direct Debit or Tax-Free Childcare transfer. Payment by other methods (childcare vouchers, electronic bank transfer, standing order, debit card and credit card) are welcome but will incur a monthly processing charge of £5. This will be added to all accounts not set up for payment by Direct Debit or TFC. Invoices are sent electronically. An additional £5 per month will be charged to send invoices by post. Please note that we do not accept cash or cheques. For details see our Terms and Conditions overleaf.

Paying by Tax-Free Childcare: TFC can be used to pay for all your fees, including the Bear Necessities. It is recommended that Parents / Carers pay by TFC as the Government subsidise your payments by up to 25%. See [Best Start in Life](#) for more information and to apply.

Terms and Conditions of Sale - Mama Bear's Day Nursery Ltd, Cranford Avenue, Weymouth

Age of admittance

Children are welcome from ages 3 months to 5 years. All parents / carers must complete a registration form, detailing in full any health, dietary, medical, medicinal, allergic or other special needs, the sessions required and Direct Debit details.

Fee schedule

Fees are payable in accordance with the published tariff. Fees quoted are per child. Reductions in fees as a result of a change in age or a sibling joining the nursery will take effect at the beginning of the month following the event. Fees are due on the first day of each calendar month in advance, payable by Tax Free Childcare or Direct Debit. Payment by other methods are welcome but a valid Direct Debit is required for all accounts (including early years entitlement only), except those who pay in full through the Tax Free Childcare scheme. Not having a valid Direct Debit in place will incur an administration fee of £5 per month. Debit and credit card payments should be made by phone by calling Mama Bear's Finance office on 0117 958 2030.

Invoices are sent electronically by email. If you would prefer to receive a paper invoice by post we will make a monthly charge of £5 to cover the additional cost of this (this includes Early Years Entitlement-only places). It is essential that you quote your Bill Payer Reference for all payments, especially bank transfers and childcare vouchers. If paying by Tax-Free Childcare please advise us in advance of your TFC payment reference number. This will help us identify your payment and credit the correct account. Your Bill Payer Reference can be found on your invoice and your Tax-Free Childcare payment reference number can be found on-line.

Fees are invoiced monthly in advance, calculated on a sessional basis. No charge is made for the working days (i.e. non-bank holidays) when the nursery is closed over Christmas. There is no reduction for other holidays or child absence (see 'Holidays' below). When registering for a place (excluding EYE-only sessions), the registration fee is payable with the completed Registration Form. This non-refundable fee secures the place in the nursery or on the waiting list, depending on availability. Where a child does not subsequently take up their place the registration fee is non-refundable. The registration fee does not apply to EYE-only sessions but will be charged if additional sessions are booked. Mama Bear's Day Nursery Limited reserves the right to recover costs in full and to charge interest (both before and after any judgement) on overdue accounts at the rate of 2% per month until payment is made in full. Any payment returned by the bank or cancelled by yourself will incur an administration charge of £10.

Term time only places (college students and staff only):

Term time only places are available for children of college students and staff only and are subject to availability.

Funded Places (Early Years Entitlement) for qualifying children from nine months old

- Children attending all year round:** Funded places are available for up to 24 hours a week to qualifying families for 47.5 weeks of the year. These hours can be taken across any of our sessions during funded periods published annually in our Early Years Entitlement Policy. See [Best Start in Life](#) for more information on who qualifies and to apply. As the funding does not cover the costs of meals, snacks, nappies, other consumables, and non-curricular services & resources, these are provided as a separate "Bear Necessities" package.
- College children attending term time only:** Funded places are available for up to 30 hours a week to qualifying families for 38 weeks of the year. These hours can be taken across any of our sessions during the term dates published annually in our Early Years Entitlement Policy. See [Best Start in Life](#) for more information on who qualifies and to apply. As the funding does not cover the costs of meals, snacks, nappies, other consumables, and non-curricular services & resources, these are provided as a separate "Bear Necessities" package.

All children: Funded sessions / hours can be combined with fee-paying sessions to give the best fit for your family's needs. Where sessions are part-funded, the balance is charged at the prevailing hourly rate for that session. Where a booking pattern consists of varying session lengths, funding is first applied to the longer sessions.

* **"Bear Necessities"** is our package of care items including everything your child needs that isn't covered by the Government funding: meals (breakfast, lunch, tea, as appropriate), healthy snacks, drinks, fruit, weaning food, nappies, wet wipes, barrier and sun creams, as well as all other consumables, enrichment and non-curricular services & resources that are not covered by the funding but otherwise included in fee-paying sessions. This service is automatically provided to all funded sessions and invoiced at the hourly rate as published in our Price List unless the parent opts-out. If you would like to opt-out of this service and provide these items yourself please discuss this with the Nursery Manager before the beginning of the funding period (term). The Nursery Manager will explain our Policy on opting-out and what alternatives you will need to supply in lieu. Should you wish to commit to this, you will be asked to sign and adhere to an Opting-Out Agreement. Opting-out cannot be requested once the funded period (term) has begun. Non-compliance with our Opting-Out Policy can cause significant, serious disruption to your child's and other children's care and welfare and impacts the safe running of the nursery. Repeated infringements will be addressed proportionately but may annul the Agreement to opt-out, resulting in charges being applied for the full term or your child's place being withdrawn.

All Entitlements start from the term after the child's qualifying birthday. For full details and term dates please see our Early Years Entitlement policy. The dates of the funded weeks vary from year to year and are published in advance. Any hours that fall outside of the funded entitlement are charged in line with our standard tariffs. Under scheme rules, parents / carers registering for funded-only sessions are not required to pay a registration fee, however a registration fee will be required to access all other sessions. Funded sessions are offered in line with the DfE and Local Authority's Codes of Practice and are subject to their terms and conditions. All sessions, funded and non-funded, are subject to availability.

Please note that it is the parent's responsibility to ensure that their application for funding is made in line with the LEA's requirements and eligibility codes are kept up to date. Late, incomplete or invalid applications and lapsed eligibility codes may result in nursery fees being charged at our normal rates for these sessions. Scheme rules dictate that children are required to attend all funded sessions booked. Any charges imposed on us by the Local Authority for non-attendance or other infringement by the Client of the scheme rules will be passed back in full to the Client.

Holidays, absences and notice to terminate

The nursery is open for 51 weeks of the year. We are closed between the Christmas - New Year period and on all statutory Bank Holidays. Our quoted fee schedule has factored in these days to give a flat-rate throughout the year, except for December when no charge is made for the non-bank holidays when we are closed. Fees are payable at the full rate for all periods of child absence, including holidays, bank holidays and sickness. A calendar months' notice in writing or a month's fees in lieu of notice is required from the parent / carer to terminate a child's place in the nursery or reduce the number of hours normally taken by that child. Abuse of or non-adherence to the nursery's policies and procedures, Local Authority funding rules or these terms and conditions may result in the termination of your child's nursery place. Where a child's place is terminated by the nursery a charge equivalent to one month's fees will be made by the nursery in lieu of notice.

Disruptions to Service (Force Majeure)

In cases of disruption to service Mama Bear's will do everything in its power to operate the service where it is safe to do so. However, severe disruptions may require the closure of the nursery or reduction in service. In such cases fees remain payable during any period of closure. Examples of force majeure include but are not limited to extreme weather (including snow and ice), other acts of God or third parties outside of the nursery's control including disruptions to highways, public transport, utilities and industrial action.

Sickness and illness (for more information please see Policy No. 05-408)

Any child who has, or develops, an infectious illness must be kept at home. This includes conditions such as vomiting, diarrhoea, discharges, conjunctivitis, sore throat and obvious rashes. In order to prevent the spread of illness, any child suffering from vomiting or diarrhoea must be kept at home until clear of symptom for a minimum of 48 hours. Fees, where due, are payable at the full rate during the period of sickness absence from the nursery.

Late collection charges

Mama Bear's supports working families and understands the difficulties of balancing work and family commitments. To this end we do not charge parents for occasional late collection of children for up to 15 minutes after the agreed collection time. However late collection does cause significant disruption and increased staff costs. Therefore repeated late collection or collection beyond 15 minutes after the end of the session will be charged at £10 per 15 minutes or part thereof. Parents who have difficulty collecting by 6.00pm can pre-book a late collection (up to 7.00pm) but please note that a minimum of 48 hours' notice is required in order for us to arrange appropriate staff cover.

Data protection

Mama Bear's Day Nursery Ltd. is registered under the Data Protection Act 1998 (Reg. No. Z8008837) to process personal information pursuant to the provision of childcare.
